- POOL INFO**- The tiles at the Clubhouse pool have been repaired, and the broken pool furniture will be sent out for re-sliding on Tuesday. It is estimated this will take 3-4 weeks, so all the chairs should be back in mid June. Also, both pools have been switched from heat to cool. Temp is now set between 86-88.
- TRIMMING PRESERVES QUESTION**- We have received requests from some owners to trim the Preserves back. We are not allowed to do that – it is protected land. We would be fined for that. It must be done by a specialized approved company. We contract with Earth Tech Environmental. They come four times a year (in 2025 they came in Feb, May, Sept, and Dec) to determine what needs to be trimmed and they then do it. Dana is meeting with their rep on May 22.
- REGULAR TREE TRIMMING**: Leo Jr. has begun doing a hard trim of our ornamental trees and shrubs that need it. While it looks stark in its appearance, it is for the health of the trees. These trees and shrubs will grow back quickly with beautiful shape and full foliage.
- CALL FOR RULES SUGGESTIONS** – Our Rules Committee will again be reviewing our Rules and Regulations. They have already received several suggestions for some revisions and additions. The Rules Committee will first review and discuss owners’ recommendations and determine if they will advance those to the Board for a vote.
